Pope Francis has endorsed a universal basic income. Covid-19 could make it a reality in Europe.



In 2017, British Prime Minister Theresa May, faced with demands to increase nurses' stagnant wages, famously denied the existence of any "magic money tree." Ms. May's Conservative Party predecessor, Margaret Thatcher, had asserted that the U.K. government had no money of its own; only what it raised from the populace by taxation or borrowing. Most people probably thought this orthodoxy prudent. A budget deficit was a sign of bad governance, strenuously to be avoided.

Such apparent and long championed fiscal frugality by Conservatives has often gone unchallenged—until now. As the second Covid-19 wave swept Europe so too has a burgeoning conversation about Universal Basic Income that may require a reassessment of hoary thinking on deficit spending. In Scotland, as elsewhere in the United Kingdom, the discussion is not new but it has become more prominent—indeed urgent—as the political and economic response to the pandemic turned fraught The idea even got an unqualified plug from Pope Francis himself. In the recently published Let Us Dream, the pope endorsed an "unconditional lump-sum payment to all citizens" in the context of his regular calls for an economically and environmentally more equitable post-Covid world.

Francis's version of U.B.I. suggests that it be paid for through taxation. But there are other ideas about how to fund U.B.I. in circulation.

Klaus Schwab: "Great Reset" will lead to the fusion of our physical, digital and biological identity



The founder of the World Economic Forum, Klaus Schwab, recently said that the fourth industrial revolution within the framework of the Great Reset will "lead to a fusion of our physical, digital and biological identity". Thousands of Swedish people are swapping ID cards for microchips

Thousands of Swedes are having microchips implanted into their bodies so that they don't need to carry key cards, IDs, and even train tickets.

About 3,000 people in Sweden have inserted a microchip — which is as tiny as a grain of rice — under their skin over the past three years, Agence France-Presse reported.



The technology was first used in the country in 2015. The implants have already helped replace the need for a host of daily necessities. Ulrika Celsing's microchip, which is in her hand, has replaced her gym card and office key card. When she enters her workplace, the 28-year-old simply waves her hand near a small box and types in a code before the doors open, AFP said.

Last year, the state-owned SJ rail line started scanning the hands of passengers with biometric chips to collect their train fare while on board.

Politics in the Corona crisis did not come out of the blue. The "fight against viruses" began as early as the 1990s as the "fight against bio-terror". Research shows: For more than twenty years since then, pandemic scenarios have been rehearsed again and again in business games, first in the USA, later coordinated internationally, also with German participation. The titles of these exercises are reminiscent of Hollywood productions: "Dark Winter" (2001), "Global Mercury" (2003), "Atlantic Storm" (2005) or "Clade X" (2018). High-ranking officials and government representatives as well as well-known journalists were involved, most recently at "Event 201" in October 2019, including board members of large global corporations. After the World Health Organization (WHO) declared a coronavirus pandemic in 2020, many of the measures that had been tried and discussed for years were implemented globally.

Passages like this appeared in the scripts 20 years ago: "The sight of an armed military presence in American cities provokes protests against the curtailment of civil liberties (...) The question is how and to what extent we enforce these things. How much violence do you use to keep people in their homes? "In the event of a pandemic," basic civil rights such as the right of assembly or freedom of movement could no longer be taken for granted". Restrictions on freedom, but also mass vaccinations, were a regular part of the simulation games.

Rather, the exercise was designed to highlight the numerous complicated global challenges that would arise in the event of any large-scale epidemic of infectious disease, whether caused by a bioterrorist attack or a naturally occurring outbreak."

In all these exercises it was not only about a health crisis and who had the sovereignty, it was also about abolition of fundamental rights, mass vaccination and authoritarian politics without parliaments.

- May 2018 "Clade X" Exercise. Scenario: "High ranking elitist sect develop virus to reduce world's population." Thomas Daschle (one of anthrax letter receivers in 2001) took part.
- 2019 17 September 2019 Short circuit in the financial system. Had nothing to do with Coronavirus because that effect came January 2020.
- October 2019 "Event 201" The Johns Hopkins Center for Health Security in partnership with the World Economic Forum and the Bill and Melinda Gates Foundation hosted Event 201, a high-level coronavirus pandemic exercise.

Before Corona: EU developed action plan for comprehensive vaccination of the population



Two years before the corona pandemic, the EU Commission had drawn up a "road map for vaccination" for public health. Among the objectives were: "Intensive monitoring of vaccination readiness in all age groups, including healthcare workers. (...) Combating the dissemination of false information in the digital age, which is also disseminated across national borders" and the introduction of a "common vaccination card that can be shared electronically across borders".

From a document of the EU Commission (COMMISSION DEPARTMENT TO THE EUROPEAN PARLIAMENT, THE COUNCIL, THE EUROPEAN ECONOMIC AND SOCIAL COMMITTEE AND THE COMMITTEE OF THE REGIONS) entitled "Intensified cooperation in the fight against diseases preventable by vaccination", which was published on the 26th April 2018, it shows:

Among the most urgent challenges are increasing vaccination scepticism (late approval or rejection of vaccines despite available vaccination offers), the control of communicable diseases that can be prevented by vaccinations, maintaining a high vaccination rate and ensuring equal access to vaccinations for all ages and population groups. The financial sustainability of vaccination programs is also crucial to ensure greater support for monitoring the effects and effectiveness of vaccines, reducing the risk of bottlenecks and combating vaccination scepticism and its impact on immunization programs. Vaccination scepticism is increasingly worrying in Europe and worldwide, because there is a risk that it will undermine the value of vaccinations for public health."







FIGURE 2 **Historical View of Federal Reserve Balance Sheet** 25 -Great Depression: 23.0 --> End of WWII: 20.2 2011: 19.0 GDP PERCENT OF NOMINAL



Federal Reserve Balance Sheet as % of GDP


The Federal balance sheet is expected to expand by more than 40% of GDP.

Gold standard and digital dollar: The Great Reset will create a new monetary system



The world is preparing for a new Bretton Woods moment. At the end of the current "Great Reset" will be the creation of a new monetary system. But the crucial question is: Is it possible to establish a gold-covered digital dollar as an anchor currency?

Is the pandemic crisis a turning point for international economic policy? Are the old Bretton Woods institutions ready to find a new approach? (...) The Federal Reserve (Fed) has already started its new average inflation target, while other central banks have systematically lowered their inflation targets. Given well-established inflation expectations, the Fed could let the US economy run through full employment and inflation," says the Observer Research Foundation (ORF) The ORF literally: "If we are really in a historical repetition of the Bretton Woods moment, we will find that Harry Dexter White's proposals (the American position) are more influential than Keyne's ideas (the British position). The tax incentives provided worldwide are close to \$12 trillion. The central banks have lowered interest rates to zero and expanded the balance sheets by more than 7.5 trillion US dollars. This financial support must remain in place (at least until the vaccination reaches a critical mass). Early withdrawal carries the risk of economic damage, even a double drop in economic growth. A late financial crisis could return as revenge. In the meantime, debt is accumulating at record levels and there are no plans for how the world should pay for it? This must be on the agenda for 2021.


The pope's visit to the US could be an ominous sign for the stock market

Four popes have visited the United States: Pope Paul VI in 1965, Pope John Paul II seven times, Pope Benedict XVI in 2008, and Pope Francis in September 2015.

Intriguingly, three of those visits came shortly before major market downturns. John Paul II's visit in September 1987 came just over a month before the Black Monday crash, and his January 1999 visit was near the start of the tech bubble. Benedict XVI's April 2008 visit coincided with the early stages of the financial crisis.



Joe Biden has a mandate: to heal our wounded and divided nation

The fact that Mr. Biden's faith was a matter of contention mainly among Catholics and was not an impediment to his election is itself a victory for the American experiment and owes much to the pioneering efforts of the previous Catholic candidates, <u>Al Smith</u> and John F. Kennedy.



But the ultimate winner of the 2020 presidential election is the American people, who have countered a unique threat to the constitutional order and rid themselves of someone singularly ill-suited for the office of president. This is a victory for the entire country, and the men and women who won office must now govern for the entire country. A clear majority of American voters have given Mr. Biden a mandate: to repair the nation's social fabric, to bind up the nation's wounds and to bring us together as one nation. It is not a mandate to legislate a radical new order, pack the U.S. Supreme Court or pursue an extreme pro-abortion agenda.

The American people deserve leaders as open-minded and willing to work together as they are. "The challenges facing us today," Pope Francis said in his address to the U.S. Congress in 2015, "call for a renewal of that spirit of cooperation, which has accomplished so much good throughout the history of the United States.



If Biden is to heal America, he'll need his Church



ROME – By all accounts, President-elect Joe Biden is a sincere Catholic. He's spoken openly about how his beliefs have sustained him through personal pain and loss, and while there may be debate in some circles about how coherent his politics are with his faith, few contest whether he has faith in the first place. In the wake of Wednesday's chaos at the capitol, Biden may need that faith more than ever.

Arguably, not since Lincoln's first inauguration in 1861 has an incoming American president taken office facing such a divided nation. If Biden is to govern, he'll need to find a way to begin putting the pieces back together, and drawing on the resources of the Catholic Church may be among his better options.

Inevitably, Biden will have to lead the way in this national reconciliation project. His greatest asset in doing so may turn out to be his Church – having seen him through personal tragedy, Catholicism may be poised to aid him in his defining public test.

Could Catholic moral theology light the way for a new GOP?

The party is realigning around a religious, multiethnic, working-class populism, and Catholic thought could provide an ideological foundation.

For some time now, we've heard talk about an American "Catholic moment." As far back as 2012, David Gibson, director of the Center on Religion and Culture at Jesuit Fordham University (and a former Religion News Service staffer), highlighted some astonishing facts about Catholics in public life. Six of nine Supreme Court justices when Gibson wrote were Catholic. The current and previous speakers of the House at the time were practicing Catholics. Both vice presidential candidates going into the 2012 race (Joe Biden and Paul Ryan) were strong in their Catholic identity.

For a country founded in the midst of virulent anti-Catholicism and where Catholics imagine their own "penitential outsider status," in Gibson's words, this was a jolting set of facts.

In a matter of days, that same Catholic speaker of the House will look on as the Catholic former vice president is inaugurated the second Catholic president of the United States. Depending on how one is scoring at home (Justice Neil Gorsuch's relationship with Catholicism is apparently complex) seven Supreme Court justices are or have been Catholic. Should the party decide to realign around a religious, multiethnic, working-class populism — and it should — the new movement will require an ideological foundation. If 2012 was the year Catholics had come to dominate the highest levels of U.S. public life, 2021 may be the year when the highest levels of public life finally made space for the fullness of a Catholic vision.

How Biden can lead the US away from 'world war fought piecemeal'

Unprecedented global challenges set the context for incoming President-elect Joe Biden's move into the Oval Office, making his decisions about U.S. foreign policy and national security more critically important than ever. At the same time, the crises he inherits present his administration with a rare opportunity to contribute in substantial ways to a "new post-pandemic normal" toward which Pope Francis has been incessantly directing our attention.

As Biden launches his administration's approach to international relations and very serious security challenges, he would do well to draw deeply upon the values of Catholic social teaching and to absorb the insights of Pope Francis, starting with "Laudato Si', on Care for Our Common Home," Fratelli Tutti and the proposals of the Vatican's COVID-19 Commission.

Biden has already indicated his intention to take some action on the global stage that would be consistent with Catholic social teaching.

The COVID-19 pandemic is pointing to our deepest calling as a human family: to nurture a world of mercy, compassion, justice and care for one another rooted in the universal ethic of nonviolence. Spending hundreds of billions of dollars annually on weapons and preparations for war has undermined our ability to address this global pandemic.

U.S. President Joe Biden should listen with rapt attention to the pleading of Pope Francis, who in Fratelli Tutti called for an "alternative way of thinking ... a global ethic of solidarity and cooperation in the service of a future shaped by interdependence and shared responsibility in the whole human family."

A Catholic Moment

For the first time in American history, no branch of our federal government will be led by a Protestant. The president will be Catholic. The Speaker of the House is Catholic. The Senate Majority Leader will be Jewish. The Chief Justice of the Supreme Court is Catholic (and the Court as a whole is majority Catholic).

But in another sense, these facts are emblematic of a major shift in American public life, which has been evident for several decades. Mainline Protestantism once acted as the primary ballast in American public life – helping to steady us amidst the choppy waters that attend life in a democratic republic. That ballast is gone, and the long-term effects on American life can be felt all around.

There was a time when some hoped that the Catholic Church could step into the space once occupied by the Mainline Protestant churches. This was the hope articulated by a then-Lutheran pastor, Richard John Neuhaus, later a convert to Rome: a Church universal enough to counter the entropy of American pluralism and with sufficient doctrinal durability to avoid the fate of the Mainline Churches, could provide a new "religiously informed, public moral philosophy." Such a Church could provide the ballast for our public, political life. Such a Church could help define and expound the fundamental things we agree upon, which are prior to the political things we don't agree on.

Jesuit Fr. Leo O'Donovan to deliver invocation at Biden inauguration

Jesuit Fr. Leo O'Donovan, form: president of Georgetown University, will deliver the invocation at Joe Biden's presidential inauguration on Jan. 20.

O'Donovan confirmed to NCR that Biden had personally called him and invited him to offer the prayer at the inauguration, which will mark the election of the nation's second Catholic president, and that he had accepted.

O'Donovan is a longtime friend of the Biden family. In 2015, he presided at the funeral Mass for Biden's oldest son, Beau,

after he died of brain cancer at the age of 46.

Biden is known to be close with a number of Jesuit priests, and while he was vice president, he occasionally attended Mass at Holy Trinity Catholic Church in Georgetown. In 1992, when Biden's son Hunter was a senior at Georgetown, O'Donovan invited the then-senator from Delaware to give a lecture at the Jesuit university on his faith and public life. Biden told O'Donovan at the time it was the "toughest assignment he's ever had."

More recently, just days after his presidential election, on Nov. 12, Biden appeared at a virtual fundraiser for Jesuit Refugee Service, where O'Donovan now serves as director of mission. On that occasion, Biden announced that he would raise the annual admission target of new refugees into the United States to 125,000, marking a sharp increase to the Trump administration's cap of 15,000 individuals.

Catholics have a long history of participating in prayers for inaugural events. In 1937, Fr. John Ryan offered the benediction at President Franklin D. Roosevelt's inauguration. Cardinal Richard Cushing of Boston offered the invocation at the inauguration of the nation's first Catholic president, John F. Kennedy, in 1961. More recently, in 2017, New York's Cardinal Timothy Dolan provided a Scripture reading at the inauguration for President Donald Trump.
