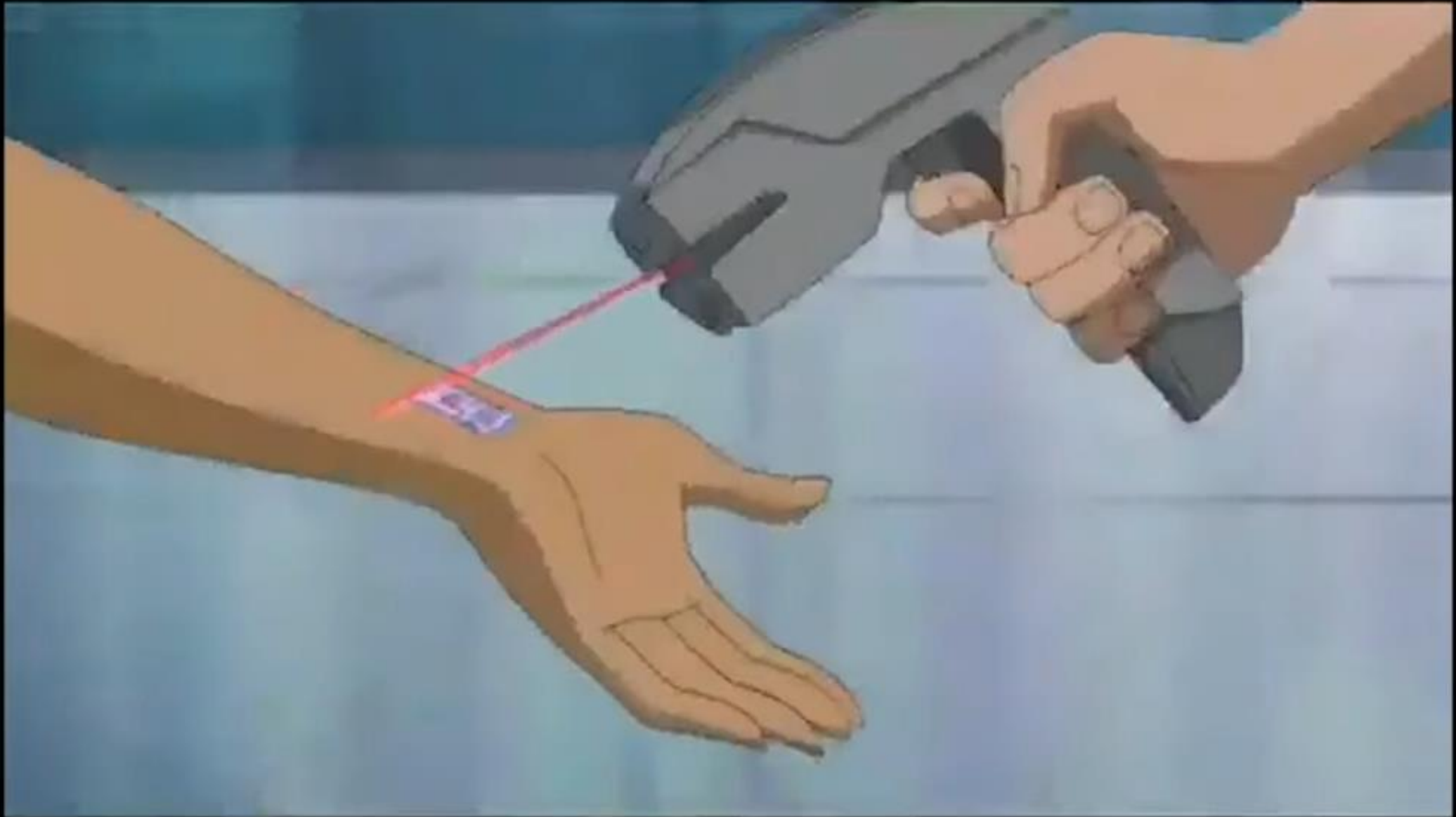

Victorian police can enter homes without a warrant

As part of new stage 4 lockdown restrictions announced this week, Victorian Premier Dan Andrews has cited harsher penalties for those found not to be following COVID-19 directions.

At the direction of health officers, authorities in Victoria can now enter any home without a warrant or permission, and take any action they deem 'necessary' to 'slow the spread'.

According to reports, the state of disaster declaration empowers the police minister, Lisa Neville, to appoint police as 'authorised officers'. When doing 'spot checks' on people's homes, if the residents did not give permission for them to enter, police will be authorised to enter without a warrant.

The Public Health and Wellbeing Act 2008 states that authorities can close any premises and “without a warrant, enter any premises and search for and seize anything that is necessary for the purpose of investigating, eliminating or reducing the risk to public health.”

Authorities may also “...direct a person or group of persons to enter, not to enter, to remain at, or to leave, any particular premises for the period of time reasonably necessary to investigate, eliminate or reduce the risk...”

On Tuesday, 172 fines were reportedly issued for breaching restrictions in a 24-hour period, totalling \$250,000. This prompted 'frustrated' police to consider using the broad powers.

Trump to mobilize military to deliver COVID vaccine to millions 'very, very quickly'

Trump said that a military general is overseeing the logistics of delivering the vaccine once it is developed.

Amid growing concerns about the safety and efficacy of a COVID-19 vaccine, President Donald Trump has

announced his administration is "all set to march when it comes to the [coronavirus] vaccine," with a military general overseeing the logistics of delivering the still-in-development product.

"I think you're going to see something that's going to be spectacular," Trump said on Thursday. "The FDA has approved things at a rate that's a tiny fraction of what it would ... take during another administration."

"We are way ahead on vaccines, way ahead on therapeutics. And when we have it, we're all set up with our platforms to deliver them very, very quickly," he added. "When a vaccine is ready, the U.S. government will deploy every plane, truck, and soldier required to help distribute it to the American people as quickly as possible," Trump said. "We have the mightiest military in the long history of humankind. We have the best and most devoted workers ever to walk the face of the Earth. And now we're combining all of these amazing strengths for the most aggressive vaccine project in history."

COVID-19 vaccines could become mandatory. Here's how it might work.

After a COVID-19 vaccine is available, you may need to get inoculated to go to the office, attend a sporting event, or even get a seat at a restaurant.

This is the future as some experts see it: a world in which you'll need to show you've been inoculated against the novel coronavirus to attend a sports game, get a manicure, go to work, or hop on a train.

Adult vaccine mandates—compelling employees and the public to inoculate themselves—aren't nearly as widespread, but they're not unheard of. U.S. states and cities can and have forced compulsory vaccinations on citizens. In 1901, for example, Cambridge, Massachusetts, adopted a law that required all citizens aged 21 and older to get vaccinated against smallpox. Failure to comply could lead to a five-dollar fine, or the equivalent of \$150 today. Those who challenged the order in court lost. While the enforcement of such mandates wouldn't be without its challenges, it would hardly be impossible or without precedent. To board an Emirates flight to Dubai today, for example, all passengers must present a negative COVID-19 test certificate. Once a vaccine is available, airlines could put in place sweeping regulations requiring COVID-19 vaccination certificates.

Bubble indemnity: Big Pharma firms will NOT be held accountable for side effects of Covid vaccine

A senior executive for pharmaceutical giant AstraZeneca has confirmed that his company cannot face legal action for any potential side effects caused by its Covid vaccine. Those affected will have no legal recourse.

But despite its healthy balance sheet, AstraZeneca is unwilling to be held responsible for any potential side effects of its 'hopeful' vaccine candidate. In other words, the company is completely protected, or indemnified, against lawsuits from people who are injected with their vaccine and experience negative effects, regardless of how severe or long-lasting they are.

The firm's lawyers have demanded that clauses to that effect be put in their contracts with the countries AstraZeneca has agreed to supply with its Covid vaccine. The company says that, without such guarantees of indemnity, they would not be incentivised to produce the drug. And it seems most of the countries have ceded to this demand.

DNA vaccines

Vaccination consists of stimulating the immune system with an infectious agent, or components of an infectious agent, modified in such a manner that no harm or disease is caused, but ensuring that when the host is confronted with that infectious agent, the immune system can adequately neutralize it before it causes any ill effect. For over a hundred years vaccination has been effected by one of two approaches: either introducing specific antigens against which the immune system reacts directly; or introducing live attenuated infectious agents that replicate within the host without causing disease synthesize the antigens that subsequently prime the immune system.

Recently, a radically new approach to vaccination has been developed. It involves the direct introduction into appropriate tissues of a plasmid containing the DNA sequence encoding the antigen(s) against which an immune response

is sought, and relies on the in situ production of the target antigen. This approach offers a number of potential advantages over traditional approaches, including the stimulation of both B- and T-cell responses, improved vaccine stability, the absence of any infectious agent and the relative ease of large-scale manufacture. As proof of the principle of DNA vaccination, immune responses in animals have been obtained using genes from a variety of infectious agents, including influenza virus, hepatitis B virus, human immunodeficiency virus, rabies virus, lymphocytic chorio-meningitis virus, malarial parasites and mycoplasmas. In some cases, protection from disease in animals has also been obtained. However, the value and advantages of DNA vaccines must be assessed on a case-by-case basis and their applicability will depend on the nature of the agent being immunized against, the nature of the antigen and the type of immune response required for protection.

The field of DNA vaccination is developing rapidly. Vaccines currently being developed use not only DNA, but also include adjuncts that assist DNA to enter cells, target it towards specific cells, or that may act as adjuvants in stimulating or directing the immune response. Ultimately, the distinction between a sophisticated DNA vaccine and a simple viral vector may not be clear. Many aspects of the immune response generated by DNA vaccines are not understood. However, this has not impeded significant progress towards the use of this type of vaccine in humans, and clinical trials have begun.

The first such vaccines licensed for marketing are likely to use plasmid DNA derived from bacterial cells. In future, others may use RNA or may use complexes of nucleic acid molecules and other entities. These guidelines address the production and control of vaccines based on plasmid DNA intended for use in humans. The purpose of these guidelines is to indicate:



Amid uproar over escaped GMO wheat, Monsanto tests more strains

June 4 (Reuters) - While regulators probe the discovery of an experimental genetically modified wheat long thought abandoned by biotech seed developer Monsanto Co, the company has a new line of field experiments on biotech wheat underway.

The company is no longer pursuing the same "Roundup Ready" spring wheat it designed more than a decade ago to tolerate dousings of its Roundup weedkiller, which is the strain found in a wheat field in Oregon in April. But it is developing similar strains that are genetically altered for herbicide tolerance as well as other traits, according to the company and regulatory filings.

"Our work in wheat is focused on helping improve wheat productivity, including breeding, biotechnology and improved agronomic practices," said Monsanto spokesman Lee Quarles in a statement.

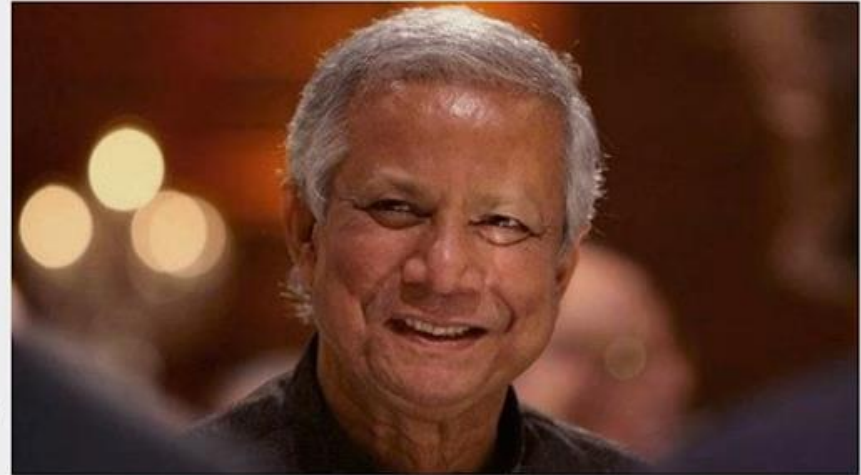
